2008 Vote Record

Each year Washington Farm Bureau provides our members with an indication of how legislators voted on issues of interest to the agricultural community. This vote record documents votes during the second session of the 60th Legislature and shows whether a legislator voted with or against Farm Bureau's position on key bills.

The bills on this vote record were selected by the Washington Farm Bureau Board of Directors. This scorecard supplies our members with a tool to help assess the performance of our elected officials. It does not provide a complete portrait of a legislator's role in behind-the-scenes efforts, their sponsorship of bills, their work on important budget provisos, their leadership qualities, or their responsiveness to constituent requests. In many cases, certain bills were not brought up for a vote, so there is no official record of a legislator's position on some issues.

We hope that this vote record will assist our members in opening a dialogue with elected officials and fostering a working relationship with them.

Unless otherwise noted, the vote listed for each bill is the one cast for the final version of the bill. Also, as we have done in years past, we have deducted one percentage point from the score for each missed vote. We understand that legislators sometimes miss votes because they are in negotiations on other bills. However, the fact remains that the legislator did not participate in a vote on a bill of importance to agriculture.

Here is a brief summary of the bills in the vote record:

Eminent Domain (HB 2016) – This bill would have prevented agencies from taking property predominantly for the purpose of increasing the tax base, economic development, and the transfer of the property to another private entity. The bill would also have required agencies to return the property to the previous owners if the property was not used for the purpose for which it was taken. It passed the House 96-1. The measure died in the Senate Transportation Committee. Farm Bureau supported this measure.

Field of Dreams (HB 2082) – This measure would have established the Field of Dreams program, which would provide college tuition credits for students working in agriculture. The measure passed the House by a vote of 96-1 and was funded in the House version of the supplemental budget. The bill did not come up for a vote in the Senate. Farm Bureau supported this measure.

Cougar Hunting Pilot Program (HB 2438) – This measure extends the five county pilot program (Ferry, Stevens, Pend Oreille, Chelan, and Okanogan) allowing the hunting of cougars with dogs for an additional three years. It also allows additional counties to join the program. Farm Bureau supported this measure. It passed the Senate 31-18 and the House 66-29.

Flooding & Erosion (HB 2525) –The bill allows counties to declare a “chronic danger” when private property is affected or threatened by two or more consecutive years of flooding or erosion. When a chronic danger is declared, the Washington Department of Fish & Wildlife must issue a permit to correct the situation. If the correction meets “fish-friendly” standards – such as soft armoring with large woody debris – it would qualify for expedited State Environmental Policy Act (SEPA) approval. Farm Bureau supported this measure. It passed the House and the Senate.

Health Insurance Partnership (HB 2537) – HIP was created last year as a first step in bringing the private health insurance market under a state-run umbrella. To address numerous problems with last year’s bill, 2SHB 2537 delays key requirements for plan choice, portability and the pooling of employee premium contributions from multiple employers. Using taxpayer-subsidies, HIP will unfairly compete with the private market for small business coverage. Basically, small businesses already providing health insurance will see their tax dollars used to subsidize their competitors. Farm Bureau opposed the bill, which passed the House 54-40, the Senate 27-22, and has been signed by the Governor.

- The Parlette Amendment would have replaced HIP with a less bureaucratic direct subsidy to assist uninsured, low-wage employees of small businesses. Farm Bureau supported the amendment, which failed 24-25.
- The Holmquist Amendment would have replaced HIP with a core benefits plan targeted specifically at the needs of young adults, ages 19-34. That group accounts for slightly more than half of the state’s uninsured and is responsible for a significant share of state-paid emergency room visits. Farm Bureau supported the amendment, which failed 22-27.

Climate Change (HB 2815) – This measure has four major components: direction for the Department of Ecology to develop a program to meet greenhouse gas emission standards; direction for the state to explore development of a cap and trade program for carbon emissions; creation of a program to reduce vehicle miles traveled; and a training program for “green collar” workers.

Farm Bureau opposed the underlying perspective that the science is settled on climate change and that modification of human activity will modify climate change. The bill does include a section that seeks recommendations regarding how agriculture and forestry may participate in a voluntary carbon cap and trade program, and directs that any offset or credit program not disadvantage Washington in relation to other states. The only vote counted on this bill was an amendment sponsored by Sen. Jim Honeyford that would have moderated the impacts of the vehicle miles traveled section. This amendment failed by a vote of 20-28-0-1. No vote on this issue was taken in the House.

Workers' Compensation (HB 3387) – This bill would prohibit the misappropriation of workers' comp trust fund, and pay damages to any ratepayer who sued to stop the misappropriation. Workers' comp trust funds are being spent on programs that are unrelated to workers' comp like minimum wage inspectors. The House declined to take the measure up in the final days of session by a vote of 32-61. Farm Bureau supported this measure.

Health Care Road Show (SB 6333) – The bill will have the Governor appoint nine citizens and four legislators to travel the state seeking citizen input about several single-payer or universal health care models, including the Canadian system. The supplemental budget includes nearly \$1.3 million for consultant studies and the work group road show. This would be the 16th health care study since Governor Gregoire has been in office. Farm Bureau opposed the bill, which passed the Senate 31-17 and the House 63-31 and was signed by the Governor.

Local Farms – Health Kids (SB 6483) – This measure creates a grant program to help put Washington produce in the hands of school children, provides for increased education related to the food production and the value of eating fresh Washington grown products, and will help facilitate connections between local farms and food banks.

Farm Bureau supported this measure. It passed the House by a vote of 93-1 and the Senate 48-1.

GMA/Climate Change (SB 6580) – This bill requires the Department of Community Trade and Economic Development to develop computer modeling and provide guidance to local governments regarding means of reducing greenhouse gas emissions through GMA related actions. The Legislature failed to clarify that these actions do not constitute grounds for legal appeals. Farm Bureau opposed this measure. It passed the Senate 31-18 and the House 58-35.

Columbia River – Lake Roosevelt (SB 6874) – The measure implements agreements made with affected parties to facilitate a drawdown of Lake Roosevelt by up to one foot. The operating budget also includes funding to facilitate this package.

Farm Bureau supported and vigorously worked this issue as a means of addressing current critical needs in the basin. This drawdown represents the first new water to be delivered under the Columbia River Water Supply Development program adopted in 2006. The measure passed the Senate 49-0 and the House 95-1.
